⇒ We involve partners because :

- WE MUST - fe. due to implications from legal acts
- WE WANT TO - we really do care about the broad acceptance of our ideas.

⇒ Why we are not so willing to involve partners?

- it generates costs and requires time;
- We are afraid of „political confrontation” - we are not capable to satisfy everyone;
- Involving partners creates risk that it will turn into a wishlist.

→ (R)evolution in partnership approach - how regions were involved in works

- on NSRF 2007-2013:
 - Regions involved in a limited scope;
 - Rather informing than codecision.
- on NSRD 2010-2020:
 - Profound cooperation;
 - Partners from regions involved from the very beginning:
 - ✓ Surveys sent to regions;
 - ✓ Thematic Working groups – with colleagues from regions as their Chairs;
 - ✓ Works on *Thesis and assumptions*.
 - Continuous cooperation on next stages.

External determinants

- ⇒ Debate on the future of cohesion policy;
- ⇒ New European and global challenges, for example globalization, demography, energy, crisis;
- ⇒ Debate on a role of territorially oriented public policies in socio-economic growth and regional policy;

National determinants

- ⇒ Introduction of a new system of development management;
- ⇒ Lack of a document concerning regional policy;
- ⇒ Review of 10 years of territorial self-government functioning;
- ⇒ New actors - metropolises. Discussions on a new multi-level system of development management;
- ⇒ Use of experiences connected with the EU funds

NSRD - content „in a pill”

- ➔ Territorial objectives instead of horizontal ones;
- ➔ Focus on development potentials – national meets regional;
- ➔ Wider role of regional policy = coordination of sectoral policies;
- ➔ New role of regional self-governments and greater importance of Regional Development Strategies;
- ➔ Result-oriented and territorially integrated approach (concentration, territorial contract, functional areas);
- ➔ Reforms of the way of planning and implementing the regional policy;
- ➔ NsRD as a strategy outlining the territorial approach of how to programme EU funds within 2014-2020 budget.

- Objectives of regional policy
- Further decentralization
- Effective instruments
- Institutions

- ➔ Objectives and rules of regional policy
- ➔ Effective division of tasks between national and regional
- ➔ Multi-level governance and financing
- ➔ Effectiveness of the policy - instruments

- ➔ **Broad public debate, ia.:**
 - expert meetings,
 - 16 regional conferences.
- ➔ **Works on implementation of the strategy**
